Grant Career Center encompasses approximately 40 square miles in southwest Clermont County. The four home schools in the jointure are Bethel-Tate Local School District, Felicity-Franklin Local School District, New Richmond Exempted Village School District, and Williamsburg Local School District. Grant offers fourteen career-based programs housed in the main campus and two satellite programs at local districts as well as a full slate of academic programming. In addition, there are currently three full-time and several part-time adult education programs offered at the campus. The district employs 38 full-time certified, 12 non-certified, and 3 administrative staff.
